TERMS OF ADOPTION

These terms apply only to adoptions of ARM - Border Collie Rescue dogs only. Other independent rescuers represented within the ARM-BCR website may have their own terms of adoption.

The following agreement specifies what we feel is required to provide a safe and loving home for one of our rescues. Please understand that the details of the contract reflect our concern that both owner and dog have a happy life together. The conditions set forth are based on years of experience and a continuing commitment to see that our rescue dogs find safe and happy permanent homes. We hope that you will understand that considerable emotional involvement, time and energy go into insuring that our rescue dogs have the best possible second chance at life.

If I am successful in the adoption of a dog through ARM-BCR, I herein promise and agree to the following conditions.

1. To keep my adoptee as my personal responsibility, provide proper and sufficient food, water, shelter, grooming and humane treatment at all times.
2. If my adoptee has not already been spayed or neutered at the time of adoption, I AGREE TO HAVE HIM/HER SPAYED OR NEUTERED AT MY EXPENSE within thirty days. Proof of spaying or neutering will be provided in writing to ARM-BCR within ten days of surgery. I will not allow this dog to breed or be bred under any circumstances.
3. To procure veterinary care at once if my adoptee becomes sick or injured and to keep current all vaccinations against rabies, distemper, parvo, and corona viruses.
4. To provide my adoptee with an ID tag secured to a collar which will be worn at all times. In addition, ARM-BCR recommends tattooing or microchipping as a means of permanent identification.
5. To obey any and all animal control regulations governing the area in which I live, and to license my adoptee according to such regulations within one month of adoption.
6. Not to sell, trade, transfer ownership, abandon, or dispose of this dog in any way, but to notify ARM-BCR if I must relinquish custody. This includes release to family members.
7. To assume full responsibility for my adoptee's actions, and for any damage done by this dog.
8. To keep my adoptee as my household pet and companion. To insure that when outside and unattended, the dog is in a secure fenced yard or kennel run with adequate shelter from the elements. To exercise him/her on leash within a fenced yard or kennel run or by walking this dog on a leash, and to never allow him/her to run loose without adequate adult supervision. To never chain or tie this dog without being in attendance.
9. I agree never to allow him/her to be transported in the open bed of a pickup truck or similar vehicle.
10. To take my dog through a basic obedience class.
